OFFICIAL CONTEST RULES

Connoisseur Media Long Island (WALK 97.5 – WALK-FM, KJOY 98.3 – WKJY-FM, 103.1 MAXFM –
WBZO-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM)
hereinafter referred to as the “Stations”

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCO) are running a multi-station promotional contest (the “Contest”) from on or about June 30, 2023 at 12:00 am EDT which will end on or about September 3, 2023 at 11:59pm EDT (the “Promotion Dates”). The Grand Prize winner will be announced on or about September 5, 2023.

2. Entry / How To Win

- a. Contestants listening to the stations during the “contest” period will be directed to specific FREE SUMMER CONCERT SERIES EVENTS (EXHIBIT C) and/or station specific webpages for instructions on how to register to win.*
- b. Contestants will locate official promotional signage at each of the FREE SUMMER CONCERT SERIES EVENTS that have been identified as an AARP Point of entry concert and scan the electronic code that will lead them to an online registration page. Contestants must complete the electronic entry form and click submit in order to be eligible for that specific entry action.*
- c. Contestants may also submit an electronic entry form by visiting www.KJOY.com , www.1031MAXFM.com or www.WHLI.com during the “contest” promotional period, following the links to that stations specific FREE SUMMER CONCERT SERIES webpage, clicking the ENTER HERE link, filling out and submitting an electronic entry form. Only one entry per person, per day, per station website will be valid.*
- d. A non-electronic entry form may also be obtained by sending a self-addressed stamped envelope to CMLI’s FREE SUMMER CONCERT SERIES GIFT CARD GIVEAWAY c/o Connoisseur Media Long Island 234 Airport Plaza Blvd. Suite 5 Farmingdale, NY 11735. One entry per day per person using this method will be valid. Entries and entry requests that go undelivered will be disqualified. Connoisseur Media Long Island is not responsible for entries, entry requests or non-electronic entry forms that are delayed and/or are delivered after the contesting period or entries, entry requests or non-electronic entry forms that go undelivered.*

- e. *On or about September 5, 2023, Connoisseur Media Long Island Judges will choose contestants by random draw from all eligible entries. The contestants will be notified via phone and will be awarded one of two runner-up prizes or the one Grand Prize.*

4. Winner Selection / Odds / Prizes

- b. *No one entry will have better odds of being selected.*

If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.
