

KJOY 98.3's LYRICAL LU'AU CONTEST

OFFICIAL CONTEST RULES

Connoisseur Media Long Island (WALK 97.5 – WALK-FM, KJOY 98.3 – WKJY-FM, 103.1 MAXFM – WBZO-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM) hereinafter referred to as the “Stations”

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCO) are running a multi-station or single station promotional contest (the “Contest”) from on or about April 25, 2024 at 12:00 am EDT which will end on or about April 3, 2024 at 11:59pm EDT (the “Promotion Dates”). The Grand Prize winner will be announced on or about May 29, 2024.

2. Entry / How To Win

- a. ***Potential qualifiers will listen to KJOY 98.3 weekdays during the “contest” promotional period for the “Lyrical Lu’au Announcement” (A line from a song that will contain a blank in place of the actual known lyric) which will be announced at or about 7:00am, 11:00 AM and 3:00 PM***
- b. ***When a “Lyrical Lu’au” is announced, the listener must visit www.kjoy.com and follow the instructions to reach the contesting and entry form submission page. Once on the contesting and entry form submission page, the listener must successfully submit an electronic entry form by completing all of the required fields, enter the corresponding missing word that fills the blank for that specific “Lyrical Lu’au Announcement” and clicking submit, within 10 Minutes of the announcement being made.***
- c. ***A physical entry form may also be obtained by sending a self-addressed stamped envelope to KJOY 98.3 Lyrical Lu’au CONTEST REQUEST c/o Connoisseur Media Long Island 234 Airport Plaza Blvd. Suite 5 Farmingdale, NY 11735. Three separate entries per day per person using this method will be valid. Entries and physical entry form requests that go undelivered will be disqualified. Connoisseur Media Long Island is not responsible for entries or entry requests that are delayed and/or are delivered after the contesting period or entries or entry requests that go undelivered.***
- d. ***On or about June 1, 2024, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the Grand Prize.***

4. Winner Selection / Odds / Prizes

- a. On or about June 1, 2024, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the grand prize.**
- b. No one entry will have better odds of being selected.**
- c. Odds of winning are based on number of entries received. Final odds of being selected the winner will only be calculable after the contest period ends and will be determined by the total number of eligible entries recorded during the contesting period.**
- d. The entry selected as the winner will be notified via the phone number given at the time of qualification. If the contestant that submitted the selected entry is unable to be reached in a timely manner as decided by the station judges, another entry may be selected at random. Once connection with the contestant that submitted the selected qualifying entry is made and verified, the winner will receive the Grand Prize as described below in exhibit B.**

5. Acceptance and Delivery of Prize

If selected, the Grand Prize must be accepted as awarded as described below in exhibit B. The Grand Prize and all elements of the prize are non-transferable. Inability to accept the Grand Prize or unwillingness to use the Grand Prize or any element of the Grand Prize as delivered will result in forfeiture. Not redeemable for cash value.

6. Conditions / Eligibility

- a. All Contest(s)/Prize(s) are subject to Federal, State and local regulations and laws and are void where restricted or prohibited by law. This Contest is governed by U.S. law and is void outside the United States.**
- b. Contest is open to legal U.S. residents who reside in Nassau, Suffolk and Queens Counties and who are age 18 or older. Participants and winner(s) must be legal U.S. residents.**
- c. No "duos," groups or teams will be allowed to enter together. Any ties, disputes, conflicts, questions or concerns regarding the Contest and/or the prize(s) will be determined by CONNCOS, whose decision(s) is final.**

- d. Participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function may not be allowed to participate unless they enter their correct area code and telephone number. CONNCOS disclaims all liability for the inability of a participant to complete or continue a text or telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond CONNCOS control, or otherwise. CONNCOS disclaims all liability for any delays, mis-delivery, loss or failure in the delivery of any item sent by mail, courier, express, electronic transmission or other delivery method. CONNCOS is not responsible for mechanical, technical, electronic, communications, telephone, cellular, computer, hardware or software malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the contest, and any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in this contest. - g. By participating, all participants and winner(s) grant CONNCOS the permission to use their names, characters, photographs, voices and likeness in connection with the promotion (via print, broadcast or other forms of media) of this and other contests and waive any claims to royalty, right, compensation or remuneration for such use.**
- h. not limited to, by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud or any other causes beyond the reasonable control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest and randomly draw from those entries received up to the cancellation/suspension date to award prizes. CAUTION: ANY ATTEMPT BY A PERSON TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEY'S FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.

7. Release

Contest winners agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNCOS and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s). If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.

8. Indemnity

Participants and winners agree to and do hereby indemnify and hold forever harmless CONNCOS and its agents, officers, employees, affiliates and assigns for any injuries, accidents, misfortunes, losses, damages or causes of action arising from or in connection with participation in the Contest and/or acceptance or use of any prize(s).

9. Miscellaneous

- a. *CONNCOS is considered the "Judge." Judge's decisions are final.*
- b. *CONNCOS reserves the right to end and/or modify the Contest at any time without additional notice or further compensation required, if any fraud, technical failure or other factor beyond*

the control of CONNCOS impairs the integrity or proper functioning of the Contest, as determined by CONNCOS in its sole discretion.

- c. *This Contest is void where prohibited or restricted by law*

EXHIBIT B

2024 Aulani Time (the "Promotion")

I. PRIZE COMPONENT – VACATION PACKAGE:

In furtherance of the Promotion, Disney will be responsible, at its cost and expense (unless stated otherwise herein), for providing Promoter with one (1) vacation package (the "Vacation") to be awarded to a Prize Winner ("Prize Winner") selected by Promoter. Vacation shall be awarded by Promoter and subject to the restrictions and approximate retail value ("ARV") outlined below. The Prize Winner may be accompanied by up to three (3) guests (each a "Guest", collectively "Guests" and together with the Prize Winner, the "Group").

The Vacation will consist of the following:

A. Up to four (4) round trip coach airfares for the Group between the major United States gateway airport closest to winner's residence ("Departure Airport") and Honolulu International airport ("Arrival Airport") as chosen by Disney (with possible layovers; provided, however, if the winner resides on the island of Oahu, airfare will not be provided) (airport, airline carrier and flights to be selected by Disney in its sole and absolute discretion).

B. Up to four (4) round trip ground transfers for the Group between the Arrival Airport and the Premises (provided, however, if the winner resides on the island of Oahu, transfers will not be provided) (ground transfers to be selected by Disney in its sole and absolute discretion).

C. Hotel accommodations for the Group (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for up to four (4) consecutive nights at the Premises as selected by Disney in its sole discretion (standard daily hotel parking at the Premises is not included unless winner resides on the island of Oahu).

D. A \$200.00 (Two Hundred dollar) Aulani Resort credit.

All costs and expenses not expressly stated in the Vacation Package description above are excluded and solely the responsibility of winner or guests, including but not limited to:

- Excursions;
- Travel insurance;
- Laundry service;
- Spa treatments;
- Alcoholic and specialty non-alcoholic beverages (including specialty coffee);
- Individually charged snacks and treats (including but not limited to movie popcorn, packaged candy, ice cream, gelato, pastries, and bar snacks);
- Local and long distance telephone calls;
- Wireless and internet services;
- Merchandise and souvenirs; and
- Tips and gratuities not specifically set forth above.

The approximate retail value ("ARV") of the Vacation Package is Six Thousand Forty Eight Dollars (\$6,048.00) dollars. The ARV of the Vacation Package may vary depending on point of departure and fluctuations of rates and airfares (if applicable). If the actual value of the Vacation Package is less than stated ARV, the difference will not be awarded.

VACATION PACKAGE

- Vacation Package components may not be sold, traded, transferred, or refunded. Vacation Package is not redeemable for cash. Vacation Package is non-commissionable.
- Winning package must be taken before 06/15/2025 (certain travel restrictions do apply, based on availability).
- Vacation is for the winner and up to three (3) guests of the winner's choosing. Once selected by the winner, guests cannot be changed without the express consent of Disney, which may be withheld for any reason. If the winner chooses to bring less than the allotted number of guests, the Vacation Package will be awarded in increments suitable for the actual number of participants with no substitute Vacation Package or compensation provided to the winner.
- If Vacation Package includes airfare, the winner and guests must travel together on the same itinerary, and air transportation must be round-trip from/to the Departure Airport (with possible layovers).
