

## **KJOY 98.3's THOUSAND DOLLAR MINUTE**

### **OFFICIAL CONTEST RULES**

**Connoisseur Media Long Island (WALK 97.5 – WALK-FM, KJOY 98.3 – WKJY-FM, 103.1 The Wolf – WWWF-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM) hereinafter referred to as the "Stations"**

**No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.**

#### **1. Promotion Dates**

***The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCO) are running a multi-station or single station promotional contest (the "Contest") from on or about October 10, 2024 at 12:00 am EDT which will end on or about December 5, 2024 at 11:59pm EDT (the "Promotion Dates"). The Grand Prize winner (s) will be announced within a few days of being determined a winner.***

#### **2. Entry / How To Win**

- a. ***Potential players will listen to KJOY 98.3 (WKJY-FM) during the contesting period for details.***
- b. ***Potential players will be directed to KJOY.com to submit an electronic registration form. The potential player must submit all required information and click submit in order to be added to the player registration list.***
- c. ***One physical, alternate registration form may also be obtained by sending a self-addressed stamped envelope to KJOY 98.3's Thousand Dollar Minute Player Registration Request c/o Connoisseur Media Long Island 234 Airport Plaza Blvd. Suite 5 Farmingdale, NY 11735. This is not an additional registration. This is intended for players who are unable or unwilling to submit the electronic player registration form. Connoisseur Media Long Island is not responsible for registrations or registration requests that are delayed and/or are delivered after the contesting period or entries or entry requests that go undelivered.***
- d. ***Each weekday morning during the contesting period, between approximately 7AM Eastern time and 9 AM Eastern Time, a player will be selected at random from the eligible players on the registered player list. Once contact has been made using the phone number provided on the potential player registration list, the host will confirm that the player is ready. Once the player confirms they are ready, the host will begin asking up to 10 Trivia Style questions. If the player answers incorrectly to a question or if the time limit of one minute is reached, the game will be stopped, and that player will be informed that they did not win. If the player answers all 10 questions correctly before the time limit of one minute is reached, as determined by***

*the host and or KJOY 98.3 judges, the player will be informed that they are a winner and will collect the prize.*

**4. Potential Player Selection / Odds / Prizes**

- a. During the contesting period, The KJOY 98.3 Host, KJOY 98.3 Judges or Connoisseur Media Long Island Judges will choose a player by random draw from all eligible potential players on the potential player registration list. The potential player will be contacted via the phone number on their registration. - c. Odds of being selected are based on number of registrations received. Final odds of being selected to play will only be calculable after the contest period ends and will be determined by the total number of eligible registrations received during the contesting period.*

**5. Acceptance and Delivery of Prize**

- c. No "duos," groups or teams will be allowed to enter together. Any ties, disputes, conflicts, questions or concerns regarding the Contest and/or the prize(s) will be determined by CONNCOS, whose decision(s) is final.*

Participants that enable the "Caller ID" block function may not be allowed to participate unless they enter their correct area code and telephone number. *Contest winners agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNCOS and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s). If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.*
