# OFFICIAL CONTEST RULES KJOY 98.3 hereinafter referred to as the "Station"

#### 1. Promotion Dates

The Station, owned and/or operated by Connoisseur Media, LLC (CONNCOS) is running a station or multi-station promotional contest (the "Contest") beginning on or about May 4, 2025 at 12:00 am EDT and ending on or about June 6, 2025 at 11:59pm EDT (the "Promotion Dates").
